Focus on... Buffer Strips

With the changes associated with CAP reform coming into play before long, the importance of adhering to water quality standards in our rivers and the need to make the life of the operator as easy as possible, we take a fresh look at buffer strips and the rules and regulations that you need to






2, 4 or 6m buffer strip. Could be funded through ELS and great for adhering to LERAP's for pesticides. Manure heaps should be sited **10m** from a watercourse and away from land drains. They should be on as small a footprint as possible and temporary field heaps should not be in the same place for more than a 12 month period.

Want to check your buffer widths to make sure you are compliant?


Ring Teresa for your free 1m ruler or pick one up at the YF show.



Knapsack sprayers should always be used more than **1m** away from watercourses. Metaldehyde-based slug pellets should not be spread within **6m** of a watercourse. Establishing a 6m buffer would therefore allow spreading to the crop edge or consider using a ferric phosphate based pellet on the headlands. Manufactured N fertiliser should not be spread within **2m** of a watercourse.

Some active ingredients require a buffer zone, for example chlorpyrifos requires a **20m** no-spray buffer zone AND the use of LERAP 3* low-drift nozzles. Check your product labels or ask your agronomist about specific products and their buffer zone...and think about where you are turning on and off your sprayer, fertiliser spreader or slug pelleter...remember the spread behind you!

Capital Grant Scheme Applications

We received 12 applications to the grant scheme this year from the catchment, which covered pesticide filling areas linked to a biofilter or biobed, concrete yard works and watercourse fencing. The applicants will hear if they have been successful by 30th June 2014.

Reminder: Those with successful extensions for the 2013/14 year need to have their work completed and claim form submitted with invoices and receipts by 31st May 2014.



What has been found in the rivers of the catchment over the Spring?

Metaldehyde – Metaldehyde levels have remained low across the catchment this Spring – thank you. Please continue to have conversations with your agronomist about using a good quality pellet, 1.5% a.i. pellets and ferric phosphate based pellets on your farm, when planning your applications this year.

Propyzamide – Propyzamide (the active ingredient in Kerb, for example) has been detected at high concentrations in the rivers (Can, Wid, Chelmer, Ter, Pant and Blackwater) across the catchment until the beginning of March. Please continue to take care when applying this product, because the water quality impacts have been seen from the application period at the beginning of November until March.
